ORDINANCES OR RESOLUTIONS

Mayor Berry introduced Bill No. 1335:

Ordinance 1335-Use Tax On Ballot

AN ORDINANCE IMPOSING A USE TAX FOR GENERAL REVENUE PURPOSES AT THE RATE OF TWO AND TWENTY-FIVE HUNDRETHS PERCENT (2.250%) FOR THE PRIVILEGE OF STORING, USING OR CONSUMING WITHIN THE CITY OF PORTAGEVILLE ANY ARTICLE OF TANGIBLE PERSONAL PROPERTY PURSUANT TO THE AUTHORITY GRANTED BY AND SUBJECT TO THE PROVISIONS OF SECTIONS 144.600 THROUGH 144.761 RSMo; PROVIDING FOR THE USE TAX TO BE REPEALED, REDUCED OR RAISED IN THE SAME AMOUNT AS ANY CITY SALES TAX IS REPEALED, REDUCED OR RAISED; AND PROVIDING FOR SUBMISSION OF THE PROPOSAL TO THE QUALIFIED BOTERS OF THE CITY FOR

THEIR APPROVAL AT THE SPECIAL ELECTION CALLED AND TO HELD IN THE CITY ON APRIL 4, 2023.

Mayor Berry entertained a motion for the First Reading of Bill No. 1335. A motion was made by Alderman Johnson and seconded by Alderman Adams. All members voted in favor.

Mayor Berry entertained a motion for the Second Reading of Bill No. 1335. A motion was made by Alderman Johnson and seconded by Alderman Walker. A roll call vote was taken.

Voting was as follows: Alderman Johnson, yea; Alderman Adams, yea; Alderman Estes, yea; Alderman Walker, yea. Motion passes.

After hearing Bill No. 1335, read two times, passed, and approved, Mayor Berry declared Bill No. 1335 to be declared Ordinance No. 1335 this 17^{th} day of January 2023.

There being no further business, moved by Alderman Johnson, seconded by Alderman Estes and unanimously carried, to adjourn at 6:04 p.m.
