## **OLD BUSINESS**

LIABILITY INSURANCE RENEWAL

Mayor Walker stated that the General Liability Renewal was carried over from the March 10, 2025 meeting. Mark Gibbins with Ellington Insurance was present to speak with the Board. Discussion followed. Alderman Cook made a motion to renew liability insurance in the amount of \$167,745.00 with Missouri Rural Services. Alderman Hollingshead seconded. All members voted in favor. Financing was discussed due to the change from monthly payments to quarterly. Mayor Walker stated he would contact the local banks to see what financing rates they would offer. If needed, an email vote would be conducted with the options presented.

## POLICE CHIEF SALARY

Mayor Walker stated that the salary for the Police Chief needed to be discussed as the salary for an elected official can only be increased or lowered before an election is held. Discussion followed. Alderman Adams abstained from voting due to a conflict of interest. Alderman Hollingshead made a motion for a 20% increase to the Police Chief salary. Mayor Walker asked for a second. There was no second. Motion dropped. The Police Chief salary would remain the same for the four-year term.

## DEPARTMENTAL BUDGET REVIEW

Mayor Walker presented the compiled budget for fiscal year 2026 which will run from May 1, 2025 to April 30, 2026. The departments were reviewed again in order to balance the budget. Mayor Walker presented a notice from DNR regarding the SRF grant/loan that the City was awarded. Sewer rates will need to be increased in order to close. The proposed rates are listed below:
