APPROVAL OF AGENDA

APPROVAL OF MINUTES Reg. Mtg.- 04/05/21

Moved by Alderman McCrate, seconded by Alderman Johnston and unanimously carried, to approve the agenda as submitted.

Mayor Berry asked members of the Council if they had read a copy of the Minutes made available to them three days prior to the meeting. All answered in the affirmative.

Mayor Berry asked if there were any additions or deletions to the minutes. There were none.

Moved by Alderman Essary, seconded by Alderman McCrate and unanimously carried, to approve the submitted minutes for the month of April.

DEPARTMENTAL REPORTS

RONNIE ADAMS- CHIEF OF POLICE

Turned in a written report for the month of April.

GEORGE DELISLE- FIRE CHIEF

Turned in a written report for the month of April.

DeLisle stated that the payment for the fire class was coming up as the course nears completion. He also recognized the Portageville Police Dept for their assistance with recent fires.

DeLisle stated that two pieces of equipment needed to be purchased. Discussion followed. Mayor Berry asked for authorization for the Fire Department to purchase a battery charger from Banner for approximately \$650.00 and a chainsaw from Ron's Small Engines for approximately \$580.00. Alderman McCrate made a motion to authorize the above purchases with the City paying half and the Portageville Rural Fire Department paying half. Alderman Johnston seconded. All members voted in favor. The City will pay the initial bill and then invoice the Rural Fire Department for their half.

PARK BOARD

Turned in a written report for the month of April.

Mayor Berry stated that the broken equipment at the skate park would be removed by the Street Department. If the skate park were to be removed, he would like to see the additional equipment placed for sale on Gov deals.

JOEY WALTERS- STREET & SOLID WASTE SUPERINTENDENT Turned in a written report for the month of April.

JIMMY WYMAN- WATER SUPERINTENDENT

Turned in a written report for the month of April.

Mayor Berry informed the Board of Aldermen that he had scheduled a meeting with USDA for financing options on a new water plant. He will present more information at the June meeting.

TERRY WHEELER- SEWER SUPERINTENDENT Turned in a written report for the month of April.

SCOTT PATTERSON- PRE-TREATMENT COORDINATOR

No report was turned in for the month of April.

Patterson turned in a copy of the completed SRG inspection for the Board's review.

ROOSEVELT MOSBY- ANIMAL CONTROL OFFICER Turned in a written report for the month of April.

JONATHAN THACKER- CODE ENFORCEMENT

Turned in a written report for the month of April.

Alderman Johnston asked Thacker about parked cars on City streets with no current registration. Discussion followed.

PLANNING AND ZONING

Turned in a written report for the month of April.

Patty Johnson, Planning and Zoning Chairman, informed the Board of Aldermen that Planning and Zoning had denied a request on 105 West 4th Street to place a shed on the property.

ORDINANCES OR RESOLUTIONS

Mayor Berry introduced Proclamation 2021-2:

Mayor Berry entertained a motion to accept Proclamation 2021-2. Motion was made by Alderman Doering and seconded by Alderman Johnston. All members voted in favor.

OLD BUSINESS

APPROVAL OF FY 2022 BUDGET

Mayor Berry asked for a motion to approve the budget for fiscal year ending April 30, 2022. Motion was made by Alderman Johnston and seconded by Alderman McCrate. All members voted in favor.

DEPARTMENT WAGE INCREASES

Mayor Berry stated that the Board of Aldermen had budgeted starting pay for all departments except for Police and Fire to be raised to \$10.30 per hour beginning the first pay period in May. All employees currently making minimum wage (part-time) will be raised to this amount. In addition, all full-time employees except for Police will receive an 8% wage increase that will be split into two installments in May and November with the latter based upon budget review in October 2021. Temporary Salary Adjustments of \$500 net will also be given to full-time employees in November based on budget reviews held in October 2021. Mayor Berry asked for a motion to

approve the above increases. Motion was made by Alderman Doering and seconded by Alderman Johnston. All members voted in favor.

POLICE DEPT PAY SCALE

Mayor Berry stated that the Board of Alderman established a pay scale for the Police Department based on rank during budgeting sessions. The pay scale hourly rate is as follows: Administration, \$15.70; Patrol, \$15.70; Sergeant, \$16.25; Captain, \$18.54. This also sets starting pay for the Police Department at \$15.70 per hour. In addition, a \$0.50 per hour premium will be implemented beginning May 4, 2021 for officers working the night shift. Mayor Berry asked for a motion to approve the above pay scale and increases for the Police Department. Motion was made by Alderman Doering and seconded by Alderman Johnston. All members voted in favor.

BOOT REIMBURSEMENT (UNIFORMS)

Mayor Berry stated that the Board of Alderman added a boot reimbursement policy during budget sessions that allowed full-time employees in the Street, Solid Waste, Water and Sewer Departments to be reimbursed for work boots purchased by the employee up to \$150.00 per fiscal year. Mayor Berry asked for a motion to adopt the Boot Reimbursement Program for FY 2022. Motion was made by Alderman Doering and seconded by Alderman McCrate. All members voted in favor.

DUTCH ENTERPRISE PROPOSAL

Mayor Berry informed the Board of Aldermen that Dutch Enterprises can no longer do the job required at the plant. It was suggested that we find someone who can line a 12" line. The issue was tabled for now.

APPOINTMENT OF EMERGENCY MANAGEMENT DIRECTOR

Mayor Berry stated that he had two candidates that he was considering for the position of Emergency Management Director for the City of Portageville due to the resignation of Chief Adams. They were Al DeLisle and Corey Sisk. Discussion followed. Mayor Berry recommended Corey Sisk for the position. Alderman Doering made a motion to appointment Corey Sisk as Emergency Management director for the City of Portageville. Alderman Johnston seconded. All members voted in favor. Sisk was present and accepted the position.

VANDEVANTER ENGINEERING GEAR BOX REPLACEMENT (SEWER)
Mayor Berry informed the Board of Aldermen that Vandevanter Engineering had submitted a proposal to replace the gearbox and reinstall the motor at the sewer plant in the amount of \$8461.00. Discussion followed. Mayor Berry asked for a motion to accept the proposal from Vandevanter Engineering in the amount of \$8461.00. Motion was made by Alderman McCrate and seconded by Alderman Johnston. All members voted in favor,

TORNADO SIREN

Mayor Berry informed the Board of Alderman that Ameren would be charging the City to set a pole for the new tornado siren and he recommended that the City allow Blue Valley Public Safety to place the pole and install the quoted siren on Highway 162 West in the amount of \$22,278.68. Discussion followed. Mayor Berry asked for a motion to accept the above quote in the amount of\$22,278.68. Motion was made by Alderman Doering and seconded by Alderman McCrate. All members voted in favor.
