Jose Angel was present. Discussion followed. Mayor Pro-Tem Estes asked for a

motion to allow a 30-day extension to allow Jose Angel time to have the roof repair completed so work on the inside can begin. Motion was made by Alderman Johnson and seconded by Alderman Adams. All members voted in favor. The issue was carried over until the October 3, 2022 meeting.

NEW BUSINESS

Jonathan Thacker, Code Enforcement Officer, approached the Building Commission regarding Portageville Municipal Code violations at property owned by Mike Allgier located at 503 Highway 61 North. Notice was mailed, but Allgier was not present at the hearing. Discussion followed. Mayor Pro-Tem Estes asked for a motion to allow a 30-day extension for Thacker to try to personally request his presence at the next meeting. Motion was made by Alderman Hollingshead and seconded by Alderman Adams. All members voted in favor. The issue was carried over until the October 3, 2022 meeting.
