Public Hearing – Building Commission Portageville City Hall October 6, 2025

OLD BUSINESS

216 HWY 61 N

Mayor Cook noted this was the 15th non-consecutive visit for Municipal Code violations at the property owned by Mike Allgier located at 216 Highway 61 North. Discussion followed. Mayor Cook stated that Allgier had removed the dilapidated building on his own and asked that the property be removed from the Building Commission agenda. Alderman McCrate made a motion to remove

the property from Building Commission. Alderman Smith

seconded. All members voted in favor.

209 E MAIN ST

Mayor Cook noted that this was the 3rd visit regarding Portageville Municipal Code violations at property owned by Aster Newsom located at 209 E Main Street. There was no new information on this property. The issue was tabled until December 1, 2025.

1006 DELISLE AVE

Mayor Cook noted that this was the 2nd visit regarding Portageville Municipal Code violations at property owned by Andy Lane (deceased) located at 1006 DeLisle Ave. Discussion followed. The property was removed from the agenda because it has been sent to Municipal Court.

701 HUFFMAN AVE

Mayor Cook noted this was the 1st visit for Municipal Code violations at the property owned by Samantha Musgrave, but sitting on the lot owned by Lewis Rone, located at 701 Huffman Ave. Samantha Musgrave was present. Discussion followed. Musgrave stated that she would like to sign the trailer over to the City of Portageville to remove but would need some type of paperwork in order to have it removed from her property taxes. Mayor Cook stated that he would have Terry McVey, City Attorney, review the situation to obtain the necessary paperwork. An update will be given at the next Building Commission meeting.
