OLD BUSINESS

223 EAST MAIN ST

Notice will be sent stating that the owner's will have until November 13,2022 to remove any belongings they wish to salvage from demolition. Demolition is expected to commence on November 14, 2022.

500 PAYNE AVE

Jonathan Thacker, Code Enforcement Officer, approached the Building Commission regarding Portageville Municipal Code violations at property owned by Jose Angel located at 500 Payne Ave. This was the third visit for the property. Jose Angel and his son Juan Angel were present. Discussion followed. Mayor Walker asked for a motion to allow a 60-day extension to allow Jose Angel due to the fact materials are ordered but have not arrived. Motion was made by Alderman Estes and seconded by Alderman Adams. All members voted in favor. The issue was carried over until the December 5, 2022 meeting.

503 HIGHWAY 61 NORTH

Jonathan Thacker, Code Enforcement Officer, approached the Building Commission regarding Portageville Municipal Code violations at property owned by Mike Allgier located at 503 Highway 61 North. This was the second visit for the property. Allgier was present. Discussion followed. Mayor Walker asked for a motion to allow a 60-day extension as Allgier was making progress on repairing the property. Motion was made by Alderman Johnson and seconded by Alderman Adams. All members voted in favor. The issue was carried over until the December 5, 2022 meeting.
