CITY COUNCIL MEETING Portageville City Hall April 14, 2022

CALL TO ORDER

APPOINTMENT OF ALDERMAN WARD II

Mayor Walker stated that he would like to nominate James C. "Chris" Hollingshead to the position of Alderman Ward II to fill the current vacancy of the seat. Discussion followed. Mayor Walker asked for motion to approve the nomination. Motion was made by Alderman Adams and seconded by Alderman Johnston to approve the nomination. A roll call vote was taken. The vote was as follows: Alderman McCrate, yea; Alderman Adams, yea; Alderman Johnston, yea. Motion passes.

Mayor Walker asked James C. Hollingshead if he would accept the appointment. Hollingshead agreed. Mayor Walker instructed Rachel Wrather, City Clerk, to administer the oath of office to Alderman Hollingshead.
